# KQMC Zero-Tolerance Policy

Welcome to Kokomo Quarter Midget Club! As a club, we should all be proud of our facility, friends, and "family" atmosphere. To help ensure all participants at KQMC have a positive experience, we have adopted a "Zero-Tolerance Policy". Please review this document and make sure your race team is familiar with it. The KQMC Board of Directors will strictly enforce this policy.

	<b>Violation / Infraction</b>	<b>Suspension Term</b>
1	Deliberately damaging, destroying, or defacing KQMC property and facilities	Minimum 1-year, plus the cost of damages
2	Being under the influence of drugs or alcohol during racing conditions (From start of Driver/Handler meeting to the completion of tech inspections)	Minimum 180-days
3	Making any physical or verbal threat or contact toward any person at KQMC's facility (including drivers)	Minimum 1-month, and up to 4 races
4	Throwing any object in the pit area or hot shoot	Minimum 2 race weekends
5	Ignoring instructions from any track official (Handlers and Drivers)	Minimum 1 race , DQ, and done for the day
6	Violating KQMC Rules and Regulations - including but not limited to: Smoking in non-designated areas, violating KQMC Practice Policy, and cleaning tires without discarding debris	Minimum 1 race
7	Excessive yelling, comments, or obscenities toward track official, judge, handler, or driver	Minimum 1 race
8	Driver deliberately hitting another driver while on the track or in the hot shoot	Driver is DQ and done for the day
9	Driver making an offensive hand gesture toward track official	Driver is DQ and done for the day
10	Any disrespectful conduct toward the Chief Steward and / or race day official	Done for the day, and DQ'd from that class
11	Any social media posts listing the track, other tracks, any track official, family name, driver name, pictures or video criticizing any of the above	Minimum 1 race

## \*Suspension Terms

- KQMC Board can choose to suspend member, driver, and/or handler at Board's discretion.
- All Driver Suspensions are for the individual driver only.
- All Suspension Terms begin the following race date on the schedule or as noted above.
- All suspensions will be approved by Board of Directors in attendance of race event.
- Suspension Term will be determined by the Board Members in attendance on date of violation.
- Suspension Term can carry over to next calendar year.
- Multiple violations/actions within a 12 month period will receive a suspension term.
- All Suspension Terms may be adjusted due to the severity of the violation by the Board of Directors.
- Written notification of suspension term will be sent and postmarked within 5 days of violation.
- Appeals must be received in writing within 7 days of receiving written suspension notification.
- Any DQ or suspension in reference to ZTP will not be allowed to be used as a "drop" in points.
